# Agricultural Science and Technology Classes

#### Materials Required:

Ball Point Pen (Blue or Black)
Pencil
Colored Pencils/Markers
Notebook Paper
3-Ring Binder
Spiral Notebook (Journal)

\*Each student enrolled in Agricultural Science and Technology must accumulate at least 110 Supervised Agricultural Experience (SAEP) hours per semester. The 110 hours can be obtained through an approved Supervised Agricultural Experience Program (SAEP) and completion of the course. Upon completion of the course, the student may obtain 75 of the 110 hours. The remaining 35 hours may be obtained by the student completing suggested activities for outside classroom hours, or a combination of outside classroom hours and SAEP's. SAEP records must be on file to document each student's successful completion of this requirement.

#### **Participation:**

Class Participation is essential to the success of Agricultural Science Classes. You are expected to be in class each session. Because of the importance of attendance and participation, poor attendance and/or lack of participation impacts your final grade. Many of the concepts you will be tested on relate to application activities.

The make-up policy follows Allen Independent School District regulations. You are allowed one day to make up an assignment for each day missed. It is your responsibility to check for missed assignments. If you have any questions, please ask me. If you fail to complete an assignment, you will receive a zero.

#### Tardies:

Tardies will not be tolerated. You should be in the room, seated, and ready to work before the tardy bell. All personal business should be taken care of before you report to class. If you arrive to class after the attendance has been submitted, you will be counted absent. The Allen ISD tardy policy will be in effect.

#### **Mandatory Agri-Science Projects:**

Each student enrolled in an agricultural science class will be required to maintain, and complete a record book. Using the online system <a href="https://www.theaet.com">www.theaet.com</a>. Thus, each student will be required to complete a minimum 110 hours of which 75 hours must complete through outside of class assignments. Hours can be recorded in class and outside of class on the students free time.

#### **Structure of FFA**

The FFA operates on local, state and national levels. Student members belong to chapters organized at the local school level. Agricultural education instructors serve as chapter advisors.

Chapters are organized under state associations headed by an advisor and executive secretary, often employees of the state department of education. States conduct programs and host annual conventions.

The National FFA Organization, governed by a Board of Directors and a Board of Student Officers, charters state associations; provides direction, programmatic materials and support; and hosts the National FFA Convention, which draws more than 45,000 attendees each November. The National FFA Alumni Association's more than 40,000 members in 1,200 affiliates assist in the continued growth and development of active FFA programs.

#### **Applied Learning**

The agricultural education program provides a well-rounded, practical approach to learning through three components: Classroom education in agricultural topics such as plant and animal sciences, horticulture, forestry, agri-marketing, etc.; hands-on supervised agricultural career experience such as starting a business or working for an established company; and FFA, which provides leadership opportunities and tests students' agricultural skills.

## FFA Dues (Student)

Starting in the 2019-2020 school year the Allen FFA chapter has elected to affiliate. Each student enrolled in an agriculture science course will



be a member of the Allen FFA Chapter. The student membership fee for additional FFA participation is \$30 per student.

#### FFA Jackets

FFA Jackets can be purchased for \$65.00. This will include your jacket and a tie or scarf. Orders can be placed anytime throughout the year with the National FFA at <a href="www.ffa.org">www.ffa.org</a> website. This is done on your own. Please allow 4-6 weeks for delivery. All members are encouraged to purchase a FFA Jacket if they have plans of competing on LDE's or CDE's.

## Allen Junior FFA

Jr. FFA membership is open to Allen ISD students in grades 3-8. Dues for Jr. Members will be \$30.00. Joining the Jr. FFA allows the member to participate in local meetings as well as showing at local and major stock shows under the supervision of the Allen Independent School District Agriscience Teachers. Junior members must have an older sibling in the FFA program at Lowery or Allen High School to house their animal project at the Allen ISD Project Center. Animal Projects can be kept at their home. Since they are not enrolled in a high school Agriscience class they are not allowed to participate in LDE's or CDE's sponsored by UIL.

#### FFA FUNDRAISING ACTIVITIES

Graduating Seniors apply during the Spring Semester at the District Degree Check. Scholarship is based on academic rank (must be in top 25% for Houston, top 50% for the others), SAT/ACT scores (minimum 950 on SAT, minimum of 20 on ACT), and FFA activities. Students will interview at the Area Degree Check. Ten members from the Area Association will advance to state interviews to compete for these awards.

Graduating seniors must complete an application and submit it to the scholarship committee for consideration. Amounts and numbers of scholarships available will be determined by the Parents and Friends Club. Applications will be available during the Spring Semester.

#### 4. State Fair of Texas Scholarship

Graduating seniors must complete an application and submit it prior to deadline. More information can be obtained at <a href="https://www.bigtex.com">www.bigtex.com</a>.

#### 5. Agriscience Fair Competition

The Agriscience Fair offers the opportunity for members to demonstrate their agriscience abilities through a science fair competition. Scholarships are awarded on the state and national levels.

#### 6. Proficiency and Star Awards

Students can obtain various scholarships through participation in advanced awards. Students who win on the state and national levels will receive scholarships.

A unique aspect of the Agricultural Science Program is the Supervised Agricultural Experience Program (SAEP). It enables students to feed and exhibit livestock projects, develop agricultural crop or horticultural enterprises or experience the other aspects of the agricultural industry. The SAEP is a powerful



tool that teaches responsibility, time management, commitment, teamwork and sound financial practices.

<sup>\*\*\*</sup>Animals are not required to be kept at the AISD Project Center. The above costs do not reflect any charges that can occur for veterinarian fees, medication, validation, entry fees, animal insurance etc. These would be additional expenses for the project.

## Allen FFA Agricultural Mechanics Program

Students in the Allen FFA and Allen Jr. FFA have the opportunity to participate in Agricultural Mechanics shows throughout the year.

To compete in one of the shows, students will design and construct a project of wood or metal under Ag Science Teacher supervision, and exhibit the project at a show for judging.

#### Benefits of Ag Mechanics Participation:

- -Students learn hands on skills that relate directly to a career interest.
- -Students develop public speaking skills as they exhibit their project to a panel of judges.
- -Students learn the value of organization, planning, and documentation as they design, build, and document their project.
- -Ag Mechanics projects may be shown at multiple shows throughout the year.

\*\*No garage or welder at home? No problem! At various points during the construction process the supervising teacher will arrange time at Allen High School for members to work on projects in the evenings and on weekends.\*\*

Be sure to check the rules of the shows you wish to enter to ensure your project fits into a show category before starting construction. Not all shows allow all types of projects. For example: The Collin County show allows the construction of indoor wood furniture, while San Antonio does not allow indoor furniture. At Ag Mechanics Shows students have the ability to earn various prizes and scholarship monies.

At the 2018 San Antonio Stock Show there was over \$300,000 in prizes for exhibitors and \$150,000 in scholarships distributed during the AG Mechanics Show.

In the school Ag Mechanics classes there are some projects that are funded by the school and ownership of the project is retained by Allen ISD. (E.g. Shop tables, equipment for the school project facility. Should students constructing these projects as part of their coursework win tools or products from a manufacturer as a prize, the school shall retain ownership of the tools to use in the Ag Mechanics lab. Any scholarship monies won will belong to the students. Any student or group of students winning a prize with a self-funded project will be allowed to split the prizes and monies amongst themselves under the guidance of the AST.



# Overnight Trips

The opportunity to participate in the Allen FFA is a privilege extended to AISD students. Participation in the Allen FFA places a student in a position of recognition and often bestows the position of role model upon the member. Any student who elects to accept the privilege of participating in the Allen FFA must recognize that he/she is a representative of the school and district, and will be held to a higher standard of conduct than that applied to the general student body. This applies to school related and non-school related activities. The member is subject to state law, school district policies, student code of conduct, the Allen FFA



Constitution and By-laws, and University Interscholastic League (UIL) rules. Allen ISD policy governs all trips taken by FFA members. Any student found in violation of these policies will be disciplined accordingly.

- Students will follow directions given by Advisors, as well as adult chaperones.
- Students will conduct themselves in a proper manner at all times.
- Students will stay with the group at all times.
- Students will not leave the hotel or site of activity for any reason.
- Students will follow all curfew times. Lights out will be at the discretion of the advisors.
- Students must stay in the room assigned to them.
- Female students will not be allowed in rooms of male students. Male students will not be allowed in rooms of female students.
- Students will wear official dress, except when notified by the Advisors. Allen ISD dress code is in
  effect at all times.

Violations of these guidelines will not be tolerated.

# Allen FFA Extracurricular Code of Student Conduct

Participation in school sponsored activities is an excellent way for a student to develop talents, receive individual recognition, and build strong friendships with other students; participation, however, is a privilege, not a right.

Eligibility for initial and continuing participation in many of these activities is governed by state law and the rules of the University Interscholastic League (UIL)—a statewide association overseeing inter-district competition. If a student is involved in an academic, athletic, or music activity governed by UIL, the student and parent are expected to know and follow all rules of the UIL organization. [See http://www.uil.utexas.edu for additional information.] The following requirements apply to all extracurricular activities:

- A student who receives a grade below 70 at the end of a grading period in any academic class—other than an advanced placement or international baccalaureate course; or an honors or dual credit course in English language arts, mathematics, science, social studies, economics, or language other than English—may not participate in extracurricular activities for at least three school weeks. Credit by examination, correspondence courses, and Eagle Academy instruction shall not be used to gain eligibility for participation in extra-curricular activities.
- An ineligible student may practice or rehearse while suspended but they may not participate or sit with the student group during the performances or games.
- There is a seven day grace period that keeps the student eligible until the close of school one-week after the grades are released. At that time, the student must be ineligible for three full weeks.
- A grade of "I" still renders the student ineligible unless the "I" is cleared before the end of the seven-day grace period. Students regain eligibility when it is determined that they are passing all classes at the end of the next three weeks.
- A student is allowed up to 10 absences per school year not related to post-district competition, a maximum of 5 absences for post-district competition prior to state, and a maximum of 2 absences for state competition. All extracurricular activities and public performances, whether UIL activities or other activities approved by the Board, are subject to these restrictions. Playoff games are not subject to this rule.
- An absence for participation in an activity that has not been approved will receive an unexcused absence.

Additional Conduct to be addressed while participating in Allen FFA Functions; Violations of these will result in referral to the following:

- 1. Students House Principal
- 2. CTE Principal
- 3. Student Counselor

## **FFA Conduct Expectations**

The following conduct is expected of all participants. Failure to meet these expectations can result in disciplinary action by the coach or sponsor:

- Students who participate in extracurricular activities that involve competition among schools and school districts will conduct themselves in a sportsmanlike manner at all times. This includes behavior toward visiting teams or hosting teams.
- Students should arrive to practices (including workouts), meetings, and events on time and prepared.
  - In the event that you cancel your participation after the registration deadline for that contest, you will be required to refund that entry to Allen FFA. Failure to pay that back to the chapter will result in being placed on the AHS fine list.
- Students are required to show respect at all times to advisors and supporting Alumni.
- Students should follow the Allen ISD dress code.
- Students should follow the rules promulgated in the *Allen ISD Student Code of Conduct*. Failure to do so may result in additional disciplinary measures related to the student's participation in extracurricular activities as determined by the advisors.

#### **Prohibited Conduct**

Allen ISD students who participate in extracurricular activities are prohibited at all times from:

- possessing, smoking, selling, or otherwise using tobacco products including E-Cigarettes;
- possessing or using drug paraphernalia;
- possessing, selling, or delivering to another person look-alike drugs or items represented to be drugs or contraband of any kind;
- possessing, selling, giving, delivering to another person, using, or being under the influence of marijuana, alcohol, a controlled substance, or any dangerous drug;
- engaging in conduct that contains the elements of an offense relating to glue, aerosol paint, or volatile, mood-altering chemicals;
- engaging in serious misbehavior, as outlined in the Allen ISD Student Code of Conduct;
- attending any event at which underage drinking, smoking, or drug use is occurring (students will be allowed a slight concession for an amount of time long enough to determine that a violation is occurring and to leave the premises);

- riding in a vehicle containing alcohol unless a parent, guardian, or other responsible adult is present and aware of the presence of the alcohol;
- stealing;
- conduct that causes injury or harm to persons or property;
- using profanity, lewd or vulgar language, or obscene gestures;
- fighting;
- any conduct resulting in arrest and/or citations from law enforcement officers;
- inappropriate touching including "making out" in public places, sexual gestures, or exposing parts of the body that are ordinarily covered up in public;
- inappropriate behavior in public places.

Quality Counts Verification Required for all Texas Major Livestock Shows Starting in 2014, Quality Counts verification will be required for all youth exhibiting livestock (market and/or breeding) at major livestock shows in Texas (including the State Fair of Texas, Ft. Worth Livestock Show, San Antonio Stock Show & Rodeo, Houston Livestock Show and Rodeo, Star of Texas Fair in Austin, San Angelo Livestock Show, Sandhills Stock Show in Odessa, State Fair of Texas in Dallas, and Heart O' Texas Fair in Waco). The verification process will require junior exhibitors to pass an online test that measures their knowledge on quality assurance and character education content items.

The Quality Counts Program has now been in existence statewide for six years. Over this time, it has reached an average of 30,000 youth per year through the 4-H and FFA Programs. The program outcomes clearly demonstrate youth being more knowledgeable of best management practices associated with livestock projects. More importantly, the program's impact has demonstrated positive changes in personal character attributes as well as adoption of livestock best management practices.

Over the years, Quality Counts has been supported and endorsed by every major livestock show in Texas. These livestock shows have been instrumental in helping market the program statewide and have also been a strong partner regarding the educational content developed for the Quality Counts Program. In addition, these livestock shows have fully endorsed this verification process.

Starting in May, youth are able to go online to take the test and become verified. A verification number will need to be provided at the time of making an official entry into a Texas major livestock show. Thus, youth will need to have completed and passed the test before the major livestock show's entry deadline. A passing score has been determined to be 80%.

Youth educators and the major livestock shows in Texas believe strongly in Quality Counts. Collectively, they are confident that this significant step of requiring youth to be "Quality Counts Verified," starting in 2014, will strengthen and enhance the youth livestock program in Texas.



## **CDE Contest Agreement**

#### **GENERAL RULES**

- 1. 3 missed practices without an excused absence will result in removal from the team.
- 2. Students must be eligible, according to the standard UIL rules, "No Pass No Play", to participate in any contests.
- 3. State Law and school policy prohibits the use of alcoholic beverages, tobacco (including electronic cigarettes), narcotic drugs or controlled substances on any school property and during school trips. All school policies and student code of conduct rules will be in effect.

#### **DRESS CODE**

- 1. Dress code for CDE contests is a collared shirt (polo style or button up), jeans (in nice condition, no rips or tears), and closed toe, closed heel shoes. Discrepancies in dress code will be addressed by the ag teacher. The ag teacher's decision is final.
- 2. Dress code for travelling will be school dress code. No inappropriate clothing, see through clothing, or inappropriate sayings or pictures will be allowed. Discrepancies in dress code will be addressed by the ag teacher. The ag teacher's decision is final.

#### **CONTESTS**

- 1. The ag teacher coaching each team will make the ultimate decision regarding whether a team competes in a contest. This decision is final.
- 2. A list of invitational and qualifying contests will be provided to each team
- 3. In the event a student backs out of the contest after the close of registration, the student is responsible for refunding the chapter the cost of the student's entry fee. These range from \$10.00-\$30.00. If the student's failure to attend causes forfeiture of the team, the student will be held responsible for the cost of the team entry. These could range from \$40.00 \$80.00. These fees will be added to the student's obligation record if not paid before the last day of school.
- 4. Fees may be waived based upon extenuating circumstances as deemed appropriate by the ag teacher coaching the team.
- 5. If a student can't attend the area contest they are not allowed to travel to practice contest.
- 6. The top 4 performing students deemed at practice will be the students who travel to the contest. This decision is made by the teacher and is final. No weight will be given to seniority or previous participation in the contest.

## SAE/AET Record Book Grading Policy

## Agriculture Experience Tracker www.theaet.com

You/your child are/is about to start a major project in your/their Agriculture Class. I hope that they choose a fun and exciting project that can keep their interest and help them learn responsibility at the same time. This project is called an SAE project which stands for Supervised Agriculture Experience. There are several different choices of SAE's.

**Placement** - Get a job or internship (job shadow) on a farm or ranch, at an agriculture-based business (e.g. nursery, vet clinic, grocery store, feed store, hardware store, etc.), or in a school or factory laboratory. Your child will also need to keep up with any money spent or earned while working on their project. This can be a paid or unpaid placement.

Paychecks and time recorded in journal. Student must have an average of 5 hours per week or more to reach 25 hours/year of combined SAE hours. (students in practicum of Vet Science Class - min.15 hours/week)

**Research** – This project allows the student to complete an experiment type project relating to agriculture. This is a lot like a science fair project (e.g. Determine whether the phases of the moon affect plant growth, or test and determine the efficacy of different welding methods, etc.). Your child will also need to keep up with any money you spend or earn while working on your project. This project will be judged at our Ag Science Fair and could be selected to advance to the FFA Agri-Science Fair as well. See Tx FFA rules for Ag Science Fair and use The AET for documentation.

• *Time* is invested & and possibly \$. Multiple SAEs may be done to reach the min requirement of 20 hours/year of combined SAE hours

**Foundational** –This division is used for helping a student reach the SAE requirement for class that cannot invest \$ or just wants to learn more about an agriculture topic. *No* \$ is involved only *time*! For other Foundational ideas talk to your ag teacher.

 No \$ involved. Multiple SAEs may be done to reach the min requirement of 10 hours/semester of combined SAE hours

**Entrepreneurship**— Own and operate an agricultural business (e.g. a lawn care service, beef cattle show project, a garden, holiday poinsettia production and sales, etc.) This project allows students to complete a hands-on, work related project that pertains to agriculture. *\$ is invested is recorded and time* is journaled to reach a min of 20 hours/year

For animals you must have recorded:

- How did you attain the animal? Inventory purchased for resale
- Feed expenses, each time you purchase (not one entry for all)- ex. 200lbs, finisher, 14%
- De-wormer expenses (monthly for each animal except cattle may go 6 weeks between purchasing dewormer)
- Hay expenses (some will not require hay)
- Stall bedding expenses (hay/straw)
- Pen rent (\$50/feeding period or year, may be in labor exchange under Non Cash)
- At least one supply per month purchased (other, feed, brush, comb, halter, etc.)
- Any other expenses incurred: Entry fees for shows, vet bills, etc.
- Income- when sold, premiums won at shows, etc. Also show in journal
- If you won a calf scramble it goes under Finances/Non-SAE Non-Cash Entries/other/memo enter HLSR calf scramble

**School-Based Enterprise-** can be entrepreneurial or placement and takes place in a school setting outside of regularly scheduled class time. Examples of school based enterprises may include, cooperative livestock raising in a school facility; managing or working in a school garden, a greenhouse; agricultural research done at the school; agricultural fabrication

**Service-Learning**- a student-managed service activity where students are involved in the development of a needs assessment, planning the goals, objectives and budget, implementation of the activity, promotion and evaluation of project. It may be for a school, a community organization, non-profit organization. The student(s) are responsible for raising funds for the project (if funds are needed). A project must be a stand-alone project and not part of an ongoing chapter project, or community fundraiser. Service-learning SAEs may be individual or a small group effort amongst students.

The Agriculture Experience Tracker (AET) record book will be graded each week and at the end of each grading period. It will count as one test grade each 6 weeks. It is the student's responsibility to keep an accurate record of journals/expenses/incomes current. Students will have the opportunity to update record books in class, but will need to complete the actual SAE project outside of class time. Students may use a laptop, computer, ipad or the mobile version at www.m.theaet.com

#### **About the Program**







Canine Companions for Independence is a non-profit organization that breeds, raises, and trains assistance dogs to enhance the lives of individuals with a variety of disabilities. The organization relies on volunteers to raise the dogs from a young age in order to teach them basic commands and experience socialization in addition to providing them with a safe and loving home. The headquarters of Canine

Companions ® is located in Santa Rosa, California, and there is a local training center and chapter that operate out of North Texas. The Allen ISD CTE Department and Allen Agricultural Science Department have partnered with this organization to provide volunteer puppy raisers who are students at Allen High School and members of the Allen FFA chapter.

The activity of raising an assistance dog serves as a FFA Supervised Agricultural Experience (SAE) for agricultural science courses. In addition to fulfilling the requirements of Canine Companions, one must be a paid Allen FFA member in good standing and thus also enrolled in agricultural science courses at Allen High School. Due to a high volume of interested students, there is a rigorous application and screening process through both the Allen FFA chapter and Canine Companions for Independence.

As a volunteer puppy raiser, you must agree to the following:

- Provide a safe environment for a puppy who will be the only dog under one year old in the household
- Work closely with Canine Companions and the AHS program sponsors (Mrs. Schertz) while monitoring the puppy's progress and submitting monthly reports to CCI and Carbon copying Mrs. Schertz
- Attend Canine Companions approved obedience classes at the Kinkeade campus (7710 Las Colinas Ridge, Irving, TX 75063) 2x per month or scheduled training off site with Veteran Canine Companion Puppy Raiser Volunteers.
- Teach the puppy manners and basic commands
- Provide financially for the puppy's food, medical, and transportation expenses
- Feed the puppy a diet recommended by Canine Companions (Eukanuba Large Dog breed puppy)
- Provide a kennel or crate for sleeping indoors
- Provide the puppy with age-appropriate socialization opportunities such as public outings (school-sponsored as well as personal) and medical appointments
- Keep the puppy on a leash at all times unless in a securely fenced area
- Supervise the young puppy throughout the day
- Agree to return the puppy upon request to Canine Companions

You must be at least 18 years old to be a volunteer puppy raiser. Those under the age of 18 must have a parent or legal guardian as a co-applicant on the puppy raiser application (the majority of Allen FFA puppy raisers will require a co-applicant). Per Allen ISD, all parents involved in the program will be required to complete a background check.

The Allen FFA Volunteer Puppy Raising Program will abide by the UIL eligibility policy. Program members must be eligible at all times through UIL, and frequent grade checks will be put in place. The sponsors will also monitor member attendance and discipline, both initially upon application and frequently while in the program.

All puppy raisers will be given a thorough timeline detailing feeding and medical expectations as well as training and socialization directions. A puppy raiser manual will be provided as well. All program members will be expected to utilize and abide by these resources as well as others.

Puppy sitters: those who are unable to be an Allen FFA volunteer puppy raiser may qualify to be an Allen FFA puppy sitter. Puppy sitters will abide by all of the same guidelines and follow the same steps as the puppy raisers except they will not be placed with a dog. Instead, they will be available to care for and train various puppies in the program for a specific amount of time when the need arises.

<u>Puppy Sitter Defined:</u> those who are unable to be an Allen FFA volunteer puppy raiser may qualify to be an Allen FFA puppy sitter. Puppy sitters will abide by all of the same guidelines and follow the same steps as the puppy raisers except they will not be placed with a dog. Instead, they will be available to care for and train various puppies in the program for a specific amount of time when the need arises.

#### **Steps To Becoming A Puppy Raiser/Puppy Sitter**

- Attend (parents and student) Allen High School Puppy interest meeting (date to be determined by appropriate sponsors)
- Parents must attend a mandatory meeting at the training facility for Canine Companions @ 7710 Las Colinas Ridge, Irving, TX 75063 at the date specified by the sponsors.
- Students participate in scheduled training hosted by Allen FFA with our experienced puppy raiser veteran volunteers. This time frame and frequency for training will be determined by Canine Companions staff.
- Once these things are complete the following steps will begin for the project:
- 1. Student fill out Allen High School Interest Form (Google Doc)
- 2. Allen High School staff verify student's eligibility based on attendance, GPA, class schedule (Ag science course enrollment),paid FFA membership, discipline etc..
- 3. Mandatory Meeting for parents at Canine Companions campus at Irving campus- without students present.
- 4. Student and parent attend and observe a puppy class at the Irving Campus and tour the campus where the puppy's will attend puppy classes each month and will return for the remainder of the training prior to being placed with their permanent handler as an assistance dog
- 5. Student knowledge /Interest test: canine body language/behavior, basic handling, canine nutrition, daily care, grooming, basic daily health checks (illness, injury, parasites etc.)

6. If chosen by AHS staff, your family will be given the Canine Companions puppy raising application to complete and return to Becca or Jenn at Canine Companions.

- 7. Canine Companion phone interview
- 8. Canine Companion home visit (completed by local volunteer)
- 9. Placed on the puppy waitlist

Additional FAQs pertaining to the Allen FFA program include:

• What if I am no longer able to be a member of the Allen FFA chapter (there is no room in my schedule, I am graduating from high school, etc.)?

This question will most likely be answered on a case-by-case basis. For students who are graduating from high school, the protocol will be aligned with that of the Allen agricultural facility/ag barn: if the student has a younger sibling in Allen ISD, that sibling would be able to continue raising the dog through the program, even if he/she is not a member of the Allen FFA chapter.

 What if I will be gone for an extended amount of time due to a vacation, stock show, or other trip?

The student will be required to make necessary arrangements for the care of the dog while he/she is out of town and communicate these to Mrs. Schertz. If a family member is unable to watch the dog, a possible caretaker would be an Allen FFA puppy sitter. Please see above for the description of an Allen FFA puppy sitter.

• What if I become academically ineligible/placed in an alternative learning center while caring for a puppy or forced to leave the program (moving to a different city, etc.)?

Those who are selected as volunteer puppy raisers and puppy sitters are expected to display past, present, and future academic excellence. In the rare event that a program member becomes ineligible, decisions regarding the placement of the puppy that he/she is assigned will be made at the discretion of Canine Companions and the AHS program sponsors.

 Where does the puppy go during the day while I am at school? Can I take it with me to my classes?

During the day, the puppy will remain in Mrs. Schertz's classroom (K209), or another approved location (i.e. the ag hall classrooms (H116 and H117) and office, etc.) and will not be exposed to the entirety of the AHS population. As the puppy progresses with training, he/she may begin to venture outside of these places. All decisions regarding the location of the puppy will be made by the sponsors and Canine Companions when he/she is ready to come to the school.

# AISD Agricultural Science FFA Project Center

Rules

## Allen ISD Project Center Rules

The Allen Independent School District maintains the Allen FFA Project Center located at 740 Ingram Lane in Lucas, TX east of town. This center provides for those students who do not have facilities at home to keep their projects. This is an AISD learning facility; available for students in grades 9-12 enrolled in an Agriculture science Course. This is an AISD learning facility; all school rules and policies are in effect and shall be enforced. All visitors must be announced to an Ag teacher prior to their arrival, each parent and long term volunteer must be an approved AISD volunteer. This can be done from the AISD <a href="www.allenisd.org">www.allenisd.org</a> website.

This facility is open and available for housing swine, sheep, goats, and cattle. A feeder animal project can be kept only for a period of one (1) school year at the facility. No male animals capable of reproduction will be allowed at the facility. Female animals capable of breeding may stay at the AISD facility provided they are eligible to show. The following rules are currently in force. Any new rules that may become necessary will be effective immediately upon notification to the Agriscience students by the Agriscience teachers. It is our goal as a district to set, monitor, and continuously improve a strict set of rules and guidelines to be followed. This in turn should provide a safe, educational, and rewarding atmosphere that is conducive to learning.

#### These rules are to be followed by students and parents.

- 1. All projects to be kept at the facility must be pre-approved by the student's Agriscience teacher. The number of animals a student may raise at the AISD facility is limited to the available space with a maximum of 4 head of animals per student. The teacher will assign a stall or pen where the project animal will be kept.
- 2. Each student is responsible for the feeding and caring of his/her project on his/her own time and not during school time. Raising a project animal is to be a learning experience for the student. The student showing the project is to be the primary care provider for the animal.
- 3. Each project must be cared for in a proper manner (i.e., daily and sufficient feeding and watering). A student's animal may be removed from the facility after the documented incident of neglect, and will have to incur all costs during care of project during time of neglect.
- 4. Students will be responsible for keeping their individual project stall or pen clean at all times. In addition, it is the individual student's responsibility to keep his/her animal in the assigned pen. The student also has the responsibility to keep the barns and grounds around the facility free from litter, straw, hay, feed and waste. Each student is required to help with the general up-keep and management of the facility. Areas will be designated for animal waste and bedding by the Ag science teachers.
- 5. Persons responsible for intentional damage/vandalism (to the property or equipment) may be held financially responsible for repair of the damage and may have their project removed from the barn.
- 6. Any visitor taken to the facility is the sole responsibility of the Agriscience student accompanying the visitor. There will be **NO UNAUTHORIZED** visitors allowed at the Allen ISD Ag project center with the exception of parent or legal guardian or siblings. (The Allen ISD approved volunteer process is required by all in contact with Allen ISD students, but does not give you authorization to be at the Ag Project Center) Failure to comply will result in disciplinary action.
- 7. **Cleanliness** Students are required to keep projects and project areas clean at all times! Feed rooms, store rooms, wash rack, walk ways, common areas and facility grounds will be kept clean by the students using the facility. A dumpster is located at the entrance to the facility for trash disposal. Recycle containers are located in the barn area as well for feed sacks and plastics water bottles. The facilities will be double cleaned each evening after 8pm or at the morning feeding prior to school, this is for those that the evening is unpractical due to age or other club obligations. The student on the chore list is responsible for their chore area Monday through Saturday (this does not excuse the other students from cleaning their

area and main areas prior to chore cleaning). Each week Monday thru Saturday these students will maintain their chores. Parent supervision and reports to Ag Advisors is needed to monitor facility at all times. The student needing to clean in the morning prior to school must tell the parent in charge of white board and/or an advisor of their plans. Each student is to complete these chores or be reprimanded according to the Agriculture Instructors discretion. Failure to maintain proper cleanliness of the facility may result in disciplinary action as documented by the supervising Ag science teacher.

- 8. The abuse of any animal will not be tolerated. The student is responsible for proper care of his/her animal. This includes adequate nutrition and hydration for proper growth, the development of the animal project, and cleaning the pen and surrounding area. When owners are unable to be contacted, the AISD agriculture advisors reserves the right to seek treatment for any animal found to be in need of immediate emergency care. The owner will be responsible for any costs incurred.
- 9. State law prohibits the use/possession of alcoholic beverages, narcotic drugs, controlled substances, and tobacco products including E-Cigarettes are not allowed for students, adults or animals on premises, as well as the use of profane or abusive language at any school facility. Also the use/possession of firearms, shells are also prohibited. In addition, all school policies will be in effect and enforced at the agriscience facility. Violation will result in disciplinary action in accordance with the Allen ISD student code of conduct. 1. Prompt removal of animal and all property. 2. Not eligible for future FFA competitions.
- 10. The student will keep their feed / hay and equipment locked in a trash can or similar container. The Container will be located in the feed room or designated area in the barn. The school has tack boxes available and your storage will be limited to this box. Each student will be issued a box and a combo lock. All tack and feed areas are subject to search by school officials. The district lock if damaged or lost will be replaced by the exhibitor in the amount of \$25. The lock combo will be set to desired combo and master key kept by Ag department.
- 11. Insurance for animals kept at the facility is not maintained by the school district, Agriscience Departments, or FFA Chapters. If you are interested in obtaining livestock insurance please see Mrs. Schertz for further information. The loss of animals will not be the responsibility of the school district, Agriscience Departments, ag science teacher or FFA Chapters.
- 12. Due to safety concerns, the project center will be open between the hours of 6:00 a.m. and 9 p.m. Anyone present during closed hours will be considered trespassing. If you must be at the facility after dark, you should be accompanied by a parent or guardian. Time at barn is to be used for the care of your animal and not a gathering place. All visitors must be cleared with advisor **prior** to their attendance at the Ag barn. Gates are to remain closed at all times, (including day hours) each exhibitor will receive a gate code. This code is NOT to be shared with anyone other than family. Violation of this will be dealt with according to the student code of conduct. *The gates will be locked, and barn lights out at 9pm!*
- 13. Upon completion of the show season for that animal or if the student becomes ineligible to show, the animal must be removed within 2 weeks (14 days) depending on AST. Senior students must remove their animals before the last day of school (including breeding animals).
- 14. All concerns with other (not your animal) students animals are to be addressed with the teacher of that species. At **NO** time are you to assume the role of care giver for that animal or the person to reprimand for the actions unbecoming for that student. All concerns are to be directed to the Ag Science Teacher.
  - A. Any medications / vaccinations and care MUST be done with Ag Teacher approval prior to or by a veterinarian. Do not medicate other student's animals in the Ag barn.

- 15. All Students and parents are to show the most respect for one another that house animals at the AISD Agriculture Facility. Disrespect from any party is subject to reprimand and permanent removal.
- 16. Any Vet bills incurred in the year for animal needs are to be paid in full by the exhibitor upon services, the balances will not be the responsibility of the school district, Ag department, FFA chapter, Ag science teachers.
- 17. All decisions pertaining to the care and showing of an exhibitors animal must be approved by the advisor. The advisor must be informed of any medications the animal is given and when the animal is removed off the property for medical purposes. (Ex. Vet visits, weekend shows, etc.)
- 18. While participants are at a show or out of town, student's animals will be cared for by the student, a parent, or sibling of that family, or you can make arrangements with an Allen FFA member prior to the trip. It is not the advisors responsibility to find a person to care for the exhibitor's animal. This person must be a parent/guardian who is also an Allen ISD approved volunteer or exhibitors siblings. The advisor is to be informed of who is taking care of the animal and for how long.
- 19. It is required that all students exhibiting livestock, be enrolled in Agricultural Science courses for one or both semesters. Taught by an Agriculture teacher. There are no exceptions.
- 20. No Barn Fee If anything is out of place or needs maintenance attention, the student should notify the FFA advisor immediately.
- 21. Parents are to make weekly visits to the Project Center in order to understand the daily care of your child's animal project and to be supportive of your child's needs and progress. Please advise students to clean up after themselves while visiting the barn.
- 22. Students must attend all scheduled barn clean-ups for the entire work day cleaning other than personal areas, (those must be cleaned prior to scheduled barn clean up) cleaning ALL areas on property as assigned by Ag science teachers to be eligible to house an animal the following year and receive animal money checks (ex: county, alumni, All Majors). You must gain prior approval from advisor to miss or leave a barn clean up early. All Stock show checks will be mailed to the school and checks will be held until all pens are cleaned.
- 23. Team work and leadership are two things that are absolutely necessary for our animal facility to operate smoothly, violation to personal conduct and mischievous actions will result in disciplinary action set forth by the Ag science teachers and the supervising principal of the facility.
- 24. **NO DOGS** at the Ag barn! Only Authorized <u>service</u> dogs, NOT therapy support animals (Ag Teacher Approval-Required!)
- 25. Parking is at the front of the main barn or pig barn back dock is to be used to unload tack etc. so back dock is <u>not</u> a parking spot. Violations of these actions refer to the consequences of infractions at the Ag barn. Driving speed is limited to 10 mph and extreme caution should be exercised while on the Allen ISD Ag Project Center facilities.
- 26. **ALL VISITORS** to the Allen ISD agriculture project center property, that are not AISD students (this includes parents/grandparents) MUST fill out the back ground check. All parents are to complete the AISD background check by end of the first week of September. You can find the check at <a href="https://www.allenisd.org">www.allenisd.org</a> (go to departments then human resources, then to volunteer. The only <a href="https://www.allenisd.org">Authorized</a> visitors are a parent / legal guardian or siblings of the exhibitor!

- 27. A single heat lamp may be used in such a manner so as to prevent fire or injury to animal. The heat lamp must have a ceramic base and the wire must be protected to prevent electrical injury to students or animals. In warmer months a single fan mounted on the front of the pen may be used. Any additional fans must be approved by an Ag science teacher to insure proper electrical safety and outlet load. The fan / heat lamp must be UL rated and hung securely in such a manner as to avoid injury or fire and the cord must be routed so that the animal or gate cannot cause damage to the cord.
- 28. Any extension cords used must be UL rated for outdoor use, be less than 26' in length, be constructed of a minimum 14 gauge wire, and have a 3 prong plug and receptacle so as to include a ground wire. At no time should "splitters" or surge protectors be used to add receptacle capacity to any outlet or extension cord.
- 29. Attendance at the scheduled monthly FFA meetings and any additional barn meetings is required by all exhibitors to receive all pertinent information regarding our program and deadlines.
- 30. Neither AISD, its employees, volunteers, nor the FFA are responsible for damage or loss to personal property, injury of members, animal projects, guests, or family of participants.
- 31. Any student who fails to observe the standards listed above will be required to remove his or her project within 1 week (7days) after receiving notice to this effect. Offenders will be dealt with in the following manner:
  - o **First Offense**: Student will be notified (verbally and written)
  - o **Second Offense**: Student , parent and AHS Principal will be notified and dealt with according to the student code of conduct.
  - Third Offense: Student will be required to remove his or her project from the Agricultural Science Center – If a student is evicted from the facility, he/she will not be allowed back on the premises.
  - Students that are assigned to DAEP/ISS/expulsion will NOT be allowed on premises during their punishment duration, parents will be required to tend to the animal daily during that time.
     Further specific instructions will be given at that time by the school to the parents and student for future arrangements.
- If at any time the advisor feels there is a severe offense the student/animal will be immediately removed from the Allen ISD Facilities along with all personal belongings and will not be eligible to exhibit his/her project with the Allen FFA. This can occur without steps 1-3 taking place.

Following student and parent notification of third offense, if animal is not removed from the project center within one week, the animal will be sold at market by the Ag department. Any expenses incurred by this process will be deducted from the sale of the animal and any money remaining will be forwarded to the student.

When a problem or concern arises, the method to resolve it is by following a set "chain-of-command." Always begin with the supervising teacher.

- 1. Supervising Teacher
- 2. Stacy Schertz AISD Ag Science Department Head
- 3. AHS Administrator over CTE
- 4. Career & Technical Programs Coordinator
- 5. AHS Head Principal
- 6. Central Office

## Additional Project Center Guideline

The raising of livestock as a project is the most popular SAEP that is conducted at the Allen FFA Project Center. The project is a cooperative effort of the student, parent and advisor. It is designed as a training instrument to allow students the opportunity to apply information acquired in the classroom. However, there are several areas that need clarification before the student undertakes a livestock project.

- The raising of livestock on the Allen FFA Project Center is a student's privilege, not a student's right! Feeding rules, regulations and guidelines must be strictly followed in order to reap the benefits of this privilege.
- Not all animals are of suitable quality for exhibition purposes. Most animals are of commercial quality and therefore rarely
  suited for exhibition in the show ring. Only those animals of superior confirmation should be selected. Therefore, the
  agriculture science teacher should assist in the selection and ultimately approve the animal purchased for show through the
  Allen FFA.
- Only a small percentage of those animals exhibited in the show ring will actually realize a profit. Do not be misled; this is not
  an easy money making proposition. Only the best of the best will fall into this category. The ultimate purpose of the livestock
  project is to have the student learn and understand those approved practices that will allow an animal to reach its full genetic
  potential. Learning the true meaning of responsibility is another outcome of the project program.
- Animal Projects at the AISD Ag Facility (740 Ingram Ln. Lucas, TX) are limited to students enrolled in an Ag science class
  at AHS grades 9-12. The only exception is a younger sibling of an Ag Science student enrolled in an Ag science course at the
  high school grades 9-12.

#### **Eligible Livestock Projects**

Only the following livestock projects are allowed to be raised at the Allen FFA Project Center: Market Steers, Commercial Steers, Market Sheep, Market Goats, Market Swine. Livestock projects may not be moved to the Allen FFA Project Center without the notification and approval of the supervising teacher. Space is limited in every livestock project area and it is the task of the Allen FFA staff to ensure that the largest population of students can have the privilege of raising a livestock project.

All livestock projects must be PRE-APPROVED by the Ag teacher prior to their arrival at the Ag barn! Pens will be assigned to the student by the Ag teacher!

<u>Cattle, Sheep, Goats, Swine</u> – will be purchased from a reputable breeders with show quality animals <u>Expo Birds / Breeding Rabbits</u> – MUST be purchased by reputable show animal breeders.

# NOT feed store quality! (rabbits/chickens) Many of the animals from the feed store are non-pure bred and will be disqualified at the show

#### **Stock Show Eligibility**

To be eligible to participate in any livestock show or house animals at the Allen ISD Ag Project Center, students must meet the following requirements:

- 1. Be enrolled in an agricultural science class
  - Junior members must be an active dues paid member of the Allen FFA (housing their Animals at their own facility)
  - Junior members will haul their own animal to livestock shows or make arrangements to Have them at the AISD project center to be hauled by an Ag science teacher to the show.
- 2. Be a member in good standing of the Allen FFA Chapter (Dues paid for current year)
- 3. Meet UIL guidelines for academic eligibility
  - If student fails and will not regain eligibility for show entered or decides they no longer want to show the animal, the animal must be removed within 2 weeks (14 days) from the Ag Science facility
- 4. No excessive unexcused absences /tardies from school

- 5. Have paid entry fees on time and meet show requirements
- 6. Have approval of agricultural science teacher
- 7. Advisors will travel and supervise students at various stockshows throughout the year. These stockshows will be announced early so that purchases of animals can be made accordingly. Those shows will be school sponsored absences. If you choose to attend other shows, that will need to be discussed with that Ag teacher prior for entry purposes and that will not be an excused school sponsored absence.
- 8. ALL ALLEN FFA MEMBERS WILL STALL TOGETHER AT MAJOR LIVESTOCK SHOWS.

#### **Animal Cost**

The student is responsible for the initial cost of the animal as well as any expenses incurred while feeding and caring for the animal during the feeding period. This includes, but not limited to, feed costs, facility usage fees, entry fees, validation fees, transportation fees, and medical expenses.

#### **Pen Assignments**

Animals will be assigned a pen according to the Agriculture Advisor in charge of that species prior to bringing the project into the facility. Students may not move or expand pins for any reason unless approved by the agriculture advisor. No personal locks allowed on any animal pen! Breeding animals will only be allowed at the school facility with special permission of the agriculture advisor in charge of that species.

#### **Show Entries**

- The agricultural science teachers will assist in making arrangements for participation in the Collin County Youth Fair and approved major shows. Entries in all other shows will be the responsibility of the student and guardian to know show details if it is one that is non-school sponsored, Allen FFA will still submit entry for that show to allow participation.
- Only designated shows during the school year will be SCHOOL SPONSORED (excused absences) these shows will be designated at the beginning of each school year by that particular teacher in charge of said species. School excused absences will only be signed off and excused by the Ag teachers for those shows that they attend.
- An entry meeting will be held in October. ALL LIVESTOCK EXHIBITORS and PARENTS are REQUIRED to attend!
- Your personal checks will be written to Allen FFA Alumni and we have to send one check from the Alumni to the major livestock shows for all of the Allen FFA entries.
- All entries are NON-REFUNDABLE!
- Complete payment is due at time of entry meeting for (CCJLS. And all major livestock shows)

#### Travel to and from Shows

- Allen ISD Policy governs transportation procedures. Parents and Students should check with Agricultural Science Teachers for clarification before any livestock shows. Parents must attend and aid in travel arrangements for your child. Travel permission forms are required if riding with another parent to the show the form can be found at <a href="https://www.allenffa.ffanow.org">www.allenffa.ffanow.org</a> (under document tab: travel form (short form)),or in this handbook.
- The school will attend set practice shows prior to majors, you will get those details from your supervising ag teacher. Due to constraints on ag teacher schedules, we will not haul every weekend to jackpot shows with school equipment. You will be able to attend on your own with notification given to the teachers.
- Sheep / Goats Due to fungus check procedure at Collin County Junior Livestock Show the first week of January, You will need to take great caution 30 days prior to this date with limited exposure to other sheep and daily fungus checks to insure your animal does not have ringworm. If ringworm is detected on your animal at check in for county show you will be removed from the show with that animal and fees will be NON-REFUNDABLE.

#### **Discipline While at Shows**

Livestock shows are an extension of the Allen ISD Classroom; therefore students will be responsible for their personal conduct. <u>All school rules are in effect at these shows.</u>

#### **Animal Care at Shows**

While at livestock shows, each student will be responsible for all feeding, care and grooming of his/her respective animal(s).

#### **Daily Animal Care**

It is the responsibility of the student to provide the following for their livestock project and the facilities every day (including weekends, holidays, etc.):

- Fresh feed for the livestock project (minimum of twice daily for most livestock projects)
- Fresh water for the livestock project (clean water buckets or watering areas)
- Removal of manure, soiled areas, and debris from the pen
- Grooming of the livestock project
- Exercise of the livestock project
- Monitor the wellbeing of the livestock project

- Clean feed areas, alley ways, exercise areas (arena), wash racks, and grooming areas after each use
- Return all equipment to its proper storage place

#### Feed/Tack Areas

Each student will be provided with a space to utilize as a feed /tack area. It is expected that the student keep their feed area clean, organized (free from clutter), and secure (locked). The Agriscience Program is not responsible for theft or damage of student property. All feed areas are subject to inspection at any time and combination codes or keys must be provided if requested by the supervising teacher

- O School Issued tack boxes and combo locks will be issued to each exhibitor if lock is damaged or lost the student will be responsible. \$25 to replace the combo lock
- o ALL Feed and Hay must be stored in a container that a rodent **cannot** get into, (Hay and Feed) and stored in your designated area of the barn.
- These are shared areas minimized clutter and equipment stored at the AISD Ag facility

#### **Medications / Additives:**

It is prohibited to administer any type of off-label or extra-label vaccine, medication, spray, feed additive or other substance internally or externally to any livestock project without veterinarian approval and awareness of the supervising teacher. All established withdrawal times for any administered product must be strictly followed.

#### Records

The student will keep a system of records on all livestock projects that they raise. Students will log in information for the AET computerized record keeping system acknowledged by the advisors. Animals housed at the project center will be graded according to the proper care and use of the facility. See attached log sheet for your tack boxes to keep track at the Ag barn (In Handbook – Allen FFA Animal Health/weight log sheet)

#### **Equipment/Trailer Use**

Arrangements must be made for the use of any equipment belonging to the FFA. Clippers, blowers, crates, etc. must be returned in a diligent manner so that others may be able to use them. The use of livestock trailers will be limited to the agricultural science teachers. Any equipment lost, stolen or destroyed while in the possession of a student/borrower will be replaced at the expense of the student/borrower. Crates are to be sanitized after use to avoid spread of fungus. Crates are to be reserved ahead of time by calling or texting Mrs. Schertz and supervising species advisor.

#### **Personal Trailer Storage**

No personal trailers will be stored/parked at the Allen ISD project center for more than a 48 hour period. Due to liability issues.

#### **Specific Show Rules**

It is the sole responsibility of the exhibitor to be familiar with all rules pertaining to his/her livestock project (this information may include weight limits, entry requirements, age, etc.) This information may be obtained from the Agriscience teachers or by visiting the web sites of the shows you are entering (See Website Reference pages).

#### **Medications**

It is strictly prohibited to administer any type of vaccine, drug, spray, feed additive, or substance internally or externally without first receiving approval of the Agriscience teachers. All substances used on the animal must be approved for use on the animal or be recommended by the Agriscience teacher. All withdrawal times must be followed. All students are expected to read and agree to abide by the Animal Welfare Agreement that can be found on the pages following. See attached log sheet for your tack boxes to keep track at the Ag barn (In Handbook – Allen FFA Animal Health/weight log sheets.

#### **Recommendations for Feeding and Care of Animals**

The feeding and care of the animals is a very important aspect of the livestock project. Feeding is responsible for at least 50% of the success or failure of a project.

#### **Disease Prevention**

Your animal's pen must be kept clean on a daily basis. This will help reduce fly problems and help in keeping the animal clean. Regular de-worming for internal parasites and vaccinations for more serious diseases is recommended. A close examination of your animal's feces, appetite, and attitude can help you assess its general health. All medications should follow withdrawal guidelines for market animals.

#### **Invoices for Payment**

Students will be invoiced from the FFA chapter for expenses incurred for their livestock project during the feeding period. Invoices will be issued periodically and it is expected to be reconciled within thirty days from the invoice date.

#### **Additional Duties**

The safety, sanitation, and appearance of the Allen FFA Project Center are a priority. Students may be assigned additional duties on specific days. These activities will be coordinated through the supervising teacher. Those students who do not cooperate will receive disciplinary action set by the supervising teacher.

#### **Daily Care/Feeding**

The daily routine of feeding and care is very important. All animals respond well to an organized routine. They should be fed twice daily in most cases. Normally this will require at least 30 minutes in the morning and at least 60 minutes in the evening (7:30-8:00 a.m. and 4:30 p.m.-6:00 p.m. at the project center). Your feeding program will be tailored to your particular animal as recommended by your Agriscience teacher. Your choice of feeds will be advised by your Ag science Teacher

#### Care of Stalls and Bedding

The pen is to be cleaned daily.

If bedding is used, it must be approved by the Agriculture Advisor

All soiled bedding is to be promptly and properly disposed of in designated areas (outside dumpsters)

Wheelbarrows must be emptied into designated areas every time the are used and returned to their place of storage.

Do NOT over fill wagon's or wheelbarrows, if you break it you will have to pay to replace it.

No new bedding is to be placed on top of old bedding.

#### Parents/Guardians

All parents of students with animal projects at the AISD project center must physically see and monitor the student taking care of the animal to insure they understand the daily care required of the animal and to help maintain healthy, happy animals. This must take place at least once per week.

#### Daily Showmanship/practice

You and your parent need to video yourself practicing the showmanship techniques given by the ag teachers to prepare you for the show arena. 85-90% of the show ring presence and success is magnified by the finesse of the showmanship of the student while in the ring. Ag teachers will host showmanship practices to prepare you for competition, you will need to make plans to attend.

#### Halter Breaking or Teaching the animal to lead

One of the more important considerations that arise early in the feeding period is teaching the calf, lamb or goat to lead with a halter or collar, or pig to walk with a whip. The animal **must** be worked **daily**. This is no easy task and sometimes can be very time consuming. Consistency is the key. Some animals learn more quickly than others do, but normally this can be accomplished in the first several weeks. The animal must also be trained to stand correctly and calmly. This is critical, as in some cases the judge may want to handle the animal. This practice will require several additional hours each week.

#### **Approved Livestock Surgical Practices**

Many times it will be necessary to perform surgical procedures on livestock which will improve their general appearance. It is recommended to contact the veterinarian to assist with any de-horning, castration procedures, etc. However, please realize there is always the possibility for complications. The owner must accept all risks of illness or death of the animal.

#### Weighing on a Regular Basis

Knowing your animal's weight and weighing on a regular schedule is very important. Weight gain or loss is a good indicator of how well the animal is progressing. Animals should be weighed as often as feasible. It is particularly important near show time, as weight limits and weight classes are sometimes critical to placing the animal. It is also important to know the minimum and maximum weight limits for the species you are showing and the show you are entering. Please post your weights on the charts provided each week. See attached log sheet for your tack boxes to keep track at the Ag barn (In Handbook – Allen FFA Animal Health/weight log sheets

#### **Grooming Livestock for the Show**

During the latter part of the feeding period, much time must be devoted to grooming the animal. Brushing and combing your animal are important daily routines. Washing and clipping will also be done on regular intervals to get a good view of how the animal is growing and progressing. In most cases, all animals will be clipped prior to the show to meet maximum hair requirements of the show that you are entering. This does not apply to lambs. <u>Do not wash lambs until it is time to shear or show. Outside 3<sup>rd</sup> party groomers are not allowed on premises to clip: you must haul the animal yourself to them.</u>

#### **Premium Livestock Auction vs. Market Livestock Auction**

• Premium Auction (Collin County Junior Livestock Show) This type of auction is money to the kid only. The animal stays in the possession of the kid to go onto another livestock show and sell the animal for market. The buyer for your animals at the Collin County Livestock Show needs to be **prior arranged by yourself** to insure you have a buyer at the show for your

- animal. But, keep in mind the money is simply a tax write off for them. The alumni will add money to your project if you have participated in the 75% agreement throughout the year.
- Market Animal Auction The major livestock shows are market animal auctions. The animal stays at the show and the buyer takes the animal with them for a food product. At the end of the show season if your market animal has not been sold at one of the major livestock shows, it will be sold 1 week upon completion of livestock shows. The animal at that time can be processed for your consumption or you can have an arranged buyer and the animal can be processed for them and the money for the animal will go directly to the student. \* Sheep/Goats/Pigs are terminal @ those shows (They will not come home)

#### **Responsibilities to Buyers**

The student will write, gain instructor approval, and deliver a Thank You note to the individuals who provide premium money or buy their project. An official show photograph should be taken at the show and accompany the note. Proof of delivery of the Thank You note must be given before the premium/auction check will be released to the student.

#### **Animal Death**

If an animal project dies at the agriculture facility, it is the students/parents responsibility to remove the animal carcass with in 2 hours if applicable of being notified of its existence. If the carcass is not removed with in designated time frame this service will be provided at the expense of the owner of the animal project. Please immediately notify the Agriculture teacher for proper disposal techniques. If the dead carcass is removed by a AISD employee and taken to the proper disposal area the student /parent is responsible for the payment of the disposal fee.

#### End of the year procedure (regarding the pen)

All students are responsible for cleaning their pen and all working areas at the end of the season. All pens are to have shavings removed and disposed of, feed aisle cleaned up and supplies removed, pen must be bleached out after the show season. If you do not comply with these rules you will not be allowed to house an animal at the Allen ISD project center in the future.

#### Allen FFA Advisor/Ag-Science Teacher Responsibility (Project Center)

- 1. The advisor will address any issues regarding an SAE that may occur during normal working hours. The FFA advisor is not required to make emergency calls after hours for the treatment of a sick or injured SAE, but when possible will make every effort to assist when the need arises. It is always advised that if a teacher cannot be reached to contact the Veterinarian and they will determine if it is a true emergency and can come to the Ag barn to treat the animal.
- 2. The advisor may assist in selecting the SAE project and feed programs for SAE's at the project center. All feed and feed additives will be documented and shared with the Ag teacher in charge of that project.
- 3. When available, the FFA advisor may assist in the administration of medications.
- 4. The FFA advisor, AISD principals and or staff will NOT be held liable for the injury to an SAE or member when assisting a member with their SAE. This includes, but is not limited to: castration, dehorning, docking, worming, injections, hoof care, trimming or any other action that directly involves the member and FFA advisor.
- 5. The FFA advisor reserves the right to take into consideration an individual's concerns or circumstances not addressed in this SAE project agreement.
- 6. The FFA advisor reserves the right to assess and observe the animal both in the pen and outside of the pen to maximize observation of student care and to assist the student to the fullest with the care of that animal. This may include but not limited to haltering, weighing, snaring of pig, walking, rinsing off wound etc.
- 7. Student projects may be used by AISD agriculture staff for livestock judging practices, class fieldtrips, and recruitment efforts.
- 8. The Ag teacher reserves the right to move the animal at anytime if safety to the animal is a concern.

#### **Signed Barn Contract**

Deadline to turn in signed barn documents will be set by each species Ag advisor, prior to arrival of animal project. Failure to comply with those set deadlines will result in denial of animal placement on premises at Allen ISD Ag facility.

- 5. I agree not to abuse or use excessive force on my project, especially when training or exercising my animal.
- 6. I agree not to use any drugs (or unnatural alteration techniques) on my animal without the approval of a veterinarian or my advisor.
- 7. In the event that I am feeding with a group of other students, I agree that I will share the feeding and cleaning responsibilities when it is my turn.

I know that failing to meet the standards set by my FFA advisor(s) and those listed in steps 1-7 above, will be grounds for removal of my project following the third verbal or written warning from my advisor. #### **Animal Health Care Guidelines**

#### Guidelines for administering medications to Allen ISD Agri-science/FFA Program animals

- 1. If an animal is sick or appears to have unhealthy symptoms, the student must:
  - a. Contact the advisor in charge of the species
  - b. If the advisor recommends: student/parent must contact a local veterinarian (If the situation is an emergency Please contact a Veterinarian immediately)
- 2. If in the agriculture advisors judgement, the animal needs prescription medication, the following procedures must occur:
  - a. The ag advisor will notify student/parent
  - b. Veterinarians should be contacted by the student or parent. The veterinarian can prescribe over the phone and send an email/text clarifying the prescription or if available they can make a farm call. If a farm call cannot be made, the animal can be loaded into a trailer and hauled to the veterinarian by an Ag advisor or if you have your own personal trailer to haul. School trailers CAN NOT be used and hauled by personal vehicles.
  - c. If medication is prescribed to the animal, the agriculture advisor can then administer or assist the student/parent in administering the medication as directed by the veterinarian.
  - d. A copy of the prescription medication must be kept on file.
- **3.** If an Ag Advisor is not available, and a student/parent contacts a veterinarian that then prescribes medication for the animal, the following procedures must occur:
  - a. The student must notify the Ag Advisor about the animal being seen by a veterinarian.
  - b. The student must let the agriculture advisor know what the veterinarian has prescribed.
  - c. The student must give a copy of the prescription to the Ag advisor.
  - d. A copy of the prescription medication must be kept on file
  - e. The Ag Advisor can help administer or advise student/parent on how to administer the medication to the animal
